## Ancillary activities



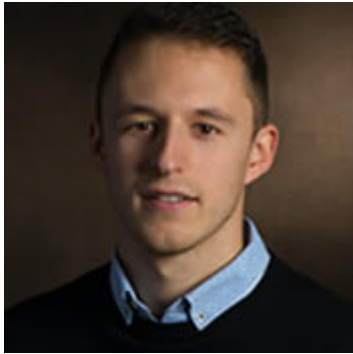
EUR attaches great value to the integrity of all its employees. To prevent conflicts of interests, it is important that third parties also have insight into ancillary activities performed by EUR employees.

## Een ongelijke verdeling van kansen (de Volkskrant)



Wie opgroeit in een kansarme buurt verdient later vaak aanzienlijk minder dan wie afkomstig is uit een betere wijk. Samen met factoren als het inkomen van de ouders en het geslacht, kan het inkomensverschil voor dertigers oplopen tot ruim dertigduizend euro per jaar. Dit blijkt uit onderzoek van onder andere Bastian Ravesteijn, universitair docent toegepaste economie van Erasmus School of Economics.
