### Erasmus School of Law Journal List 2021

#### 1. Goal Erasmus School of Law Journal List

Following the Recommendation for stimulating, rewarding and measuring research performance at Erasmus School of Law (profile committee 2020), the board of Erasmus School of Law is planning to adjust the system of research assessment. One of the activities to achieve this is compiling a list of very good and good journals.

Erasmus School of Law has a wide range of legal disciplines, each with its own journals. Between 2016-2019, staff at Erasmus School of Law published in 449 different journals, including 165 Dutch-language journals. Although the journals are divided into *refereed journals* (156) and *non-refereed journals* (293), this classification is insufficient to identify very good and good journals, nor does it give enough direction for a publication policy targeting the profile, ambition and academic reputation of the School. The board has asked the profile committee (hereafter: the committee) to make a concrete proposal for an indicative list of very good and good journals for the core disciplines of Erasmus School of Law.<sup>1</sup>

The committee has accepted this request. In Appendix II, it presents a list of very good and good Dutch and European/international legal journals that have been prioritised by a select group of Royal Netherlands Academy of Arts and Sciences (KNAW) members as the most authoritative journals. The list reflects the core disciplines and profile of Erasmus School of Law and supplements the authoritative, international *Bar Ilan Ranking* of A-star and A-qualified journals (see Appendix I). The committee focused on the external legitimacy of the list and did not attempt to produce a comprehensive list of very good and good journals. The committee advises the board to adopt the journal list in Appendix II for two years.

The committee emphasises that a mix of academic and professional publications as well as articles, annotations, monographs, (book) chapters and research reports provides important value to the research on (Tax) Law and Criminology of Erasmus School of Law. However, the task was limited to compiling a journal list. The committee refers to the framework of directional indicators (drawn up in 2020) on behalf of the board to stimulate and evaluate other research output and performance.

Although it is not the task of the committee to make policy about the usage of the journal list, it would like to provide some considerations.

Firstly, it considers the list of very good and good journals as a particularly useful instrument for young academics aiming for a career in research to help them develop a high-quality publication portfolio in order to establish a reputation and (international) recognition. The list can also guide recruitment and promotion procedures, as well as policy for writing a doctoral thesis consisting of a compilation of scholarly publications. The intention is that the list should be used as a guide and not as an instrument to assess researchers. The committee emphasises that it unanimously supports the San Francisco Declaration on Research Assessment (DORA), which wants to stop the use of the impact factor, factor of academic journals to assess the value of the work of individual researchers. The impact factor,

which does not apply to most legal journals anyway, did not play a role in compiling this list. A decisive factor for including a journal on the list was the external assessment 'authoritative'. The committee feels that an academic publication should be assessed based on the content, if possible. It regards the list of very good and good journals as a supplementary and directional instrument for the publication policy.

Secondly, the committee advises not to use the list as a 'closed shop', but as an instrument that can be used flexibly. Obviously, a publication in one of the journals on the list is an important indication. However, it is not an absolute guarantee that the article concerned is indeed of high quality. And conversely, excellent articles may well be published in journals that are not (high) on the list, including journals in other languages – besides Dutch and English – that are not or rarely included on the journal list. Because the journal landscape is always changing, it is important to continue publishing in perhaps less well-known new journals, to keep the market for publications sufficiently competitive and dynamic. For that reason, the committee proposes that, in a reasoned way, publications in equivalent journals could also be included in the personal portfolio as 'very good' or 'good'.

Thirdly, the committee suggests considering including publications in the personal research portfolio that are not on the journal list (Appendix I and II) but are earmarked as top publications in another discipline (for example, for promotion). In this way, there is a connection with rankings in other disciplines, while Erasmus School of Law maintains a close connection with disciplines with which it wishes to relate in the strategy.

Fourthly, the committee notes that in multidisciplinary research fields, it is sometimes complicated to publish cross-border articles in a journal from the list of very good or good journals. The committee wants to encourage this type of research and asks that special attention is devoted to stimulating and assessing this type of research.

Finally, it is not the intention that, by adopting the journal list in Appendix II, the researchers shift focus to publishing in Dutch journals at the expense of often more time-consuming publications in international journals. The publication strategy and the personal publication portfolio must be relevant to their research field, personal ambitions and career phase.

This memorandum explains how the supplementary list in Appendix II was produced.

# 2. Use of Bar-Ilan Ranking of very good (A-star) and good (A) English-language legal journals

Firstly, the committee looked at the usability of existing rankings of legal journals. It concluded that the list of A-star and A-qualified journals of the *Ranking Legal Publications*: *The Israeli Inter-University Committee Report (2019)*, hereafter called: *Bar-Ilan Ranking*, can be adopted by Erasmus School of Law.<sup>2</sup> Four Israeli Law Schools have jointly compiled the list based on an assessment of 900 legal publications. In this process, they took the distinctive characteristics of legal publications into account, such as publishing in both national and international legal journals. In the ranking, the journals are divided into four categories: A-star, A, B and C. The committee used all journals with A-star (very good) or A (good) qualifications for the Erasmus School of Law Journal List 2021 (see Appendix I).

Because the *Bar-Ilan Ranking* is primarily focused on the US, the committee compiled an additional list of very good and good Dutch and European/international journals relevant to the legal fields of Erasmus School of Law.

## 3. Additional list of very good and good Dutch and European/international journals

Authoritative KNAW members and some additional external specialists, as representatives of these legal fields, were asked to identify very good and good journals for eleven core disciplines and some specific legal fields at Erasmus School of Law.<sup>3</sup> The committee chose a consultation of authoritative colleagues outside of Erasmus School of Law to give external validity to the journal list. Publications in journals on this list must obviously be assessed as high quality, especially outside Erasmus School of Law. The experts were asked to identify a top three of Dutch and European/international authoritative journals for the relevant specific field. Because some journals are interdisciplinary and mentioned more frequently, the committee chose an alphabetical, School-based presentation without mentioning the legal fields.

According to the committee, this created a balanced supplement of 30 Dutch and 38 European/international very good and good journals to the *Bar-Ilan Journal Ranking*, consisting of 39 Astar and 146 A journals (see Appendix I and II). Appendix IV shows that 37% of the academic publications in journals 2017-2020 are on the Erasmus School of Law Journal List 2021.

#### 4. Appendix of journals mentioned by the heads of departments

After presenting the journal list to the professors of Erasmus School of Law in May 2021, the committee offered the heads of departments the opportunity to give a further written response to the list. Most of the responses concerned questions about the goal and use of the list. It was also suggested that twelve Dutch and nineteen European/international journals be added to the list. In response, the committee clarified the setup and objective of the list in this memorandum. However, it decided not to add any journals to the list because the committee highly values the methodology of using specialists from outside Erasmus School of Law. Consequently, several highly regarded journals for which colleagues are on the editing board are not on the list. The committee emphasises that it recognises the value of these editing duties and of our journal Erasmus Law Review. However, the committee feels that these activities and our own journal serve a different purpose, including increasing the visibility of Erasmus School of Law and offering a platform with international peer-review to our (young) researchers. For that reason, they should be valued differently. The committee explains the missing criminology journals by the interdisciplinary character of this specialist field. In the introduction, it already mentioned that

the assessment of this type of interdisciplinary research deserves special attention and that it is always possible to propose journals as equivalent in the portfolio with the necessary argumentation. One example is the *Journal of Research in Crime and Delinquency*, which has an article influence score of 1,489, making it a top journal, but is (still) not on the Erasmus School of Law Journal List 2021.

For the sake of transparency and completeness, the committee has included the twelve Dutch and nineteen European/international journals mentioned by the heads of departments in Appendix III. In two years, the committee will reconsider additions to the list.
