## Hospitality Agreement - PhD candidate

Subject to the following terms and conditions:

1. The times at which the person concerned may use the facilities mentioned above shall, with due observance of the relevant general regulations, be determined by or on behalf of the Board of Governors, the director of EFB, or the representative mentioned above;
2. The person concerned shall be obliged to comply with the EUR regulations and directions given in the interest of order, safety and health, and in general to behave as befits a good member of the university community;
3. The person concerned shall be obliged to pay for any damage and consequential damage which the EUR and any third parties may suffer as a result of any act or omission on his/her part if and in so far as he/she can be reproached for that act or omission.
4. The EUR shall not be liable for any damage which the person concerned or any third party may suffer through the actions of the person concerned, unless this liability directly ensues from a provision of mandatory law;
5. The person concerned shall be obliged to keep secret to all information of which secrecy follows from the nature of such information, all information in respect of which he/she has been informed of its confidential nature, as well as all information of which the person concerned can reasonably know or suspect that secrecy is required;
6. In the event that the activities in which the person concerned engages under this hospitality agreement are for the benefit of any third party with whom the EUR has entered into an agreement, pursuant to which the person concerned becomes involved in any way in the EUR's contract education and/or research, then the person concerned hereby declares that he/she shall render assistance in respect of the contractual obligations which the EUR has towards such third party, and that he/she shall hereby assign to the EUR his/her intellectual property rights arising from said contract education and/or research, in order to enable the EUR to fulfil its obligations arising from said agreement towards such third party.
7. In the event that a hospitality agreement is entered for a period that exceeds one year, the following applies:
  - You will be assessed periodically regarding the progress of your doctorate thesis.
  - Your hospitality agreement may be dissolved prematurely if it emerges that your doctorate thesis is not progressing.
  - Once the hospitality agreement is dissolved, if applicable, the IND will be informed.
